Computed tax during the March quarter of 2010 was \$427,147,821 a decrease of 2.53% from the March quarter of 2009. The number of businesses filing returns decreased slightly from 82,030 to 81,068 a decrease of 1.17%.

# **Computed Tax by Business Group**

Apparel showed the best increase at 5.79%. General Merchandise and Home Furnishings had double digit contractions, indicating continued softness in home building.
