THE QUARTER IN REVIEW COMPUTED TAX BY BUSINESS GROUP QUARTER ENDING SEPTEMBER 30, 2009

Computed tax during the September quarter of 2009 was \$489,882,094 a decrease of 7.65% from the September quarter of 2008. The number of businesses filing returns increased from 82,616 to 82,782 an increase of 0.2%.

Computed Tax by Business Group

During the September quarter of 2009, the Food Dealers group was the only group that had an increase in computed tax from the September 2008 quarter. Home Furnishings had the largest decrease from September 2008. September 2008 was a strong quarter because of the rebuilding that took place after the severe flooding in eastern lowa in the summer of 2008.
