If monthly wages are at least \$9,160, multiply the excess over \$9,140.00 by 5.70% (.057) and add it to the last amount in the applicable column.

For employees who do not file a 2024 IA W-4: use \$40.00 as the total allowances amount.

Example: if an employee's monthly wages are \$9,500.00 with \$120 withholding allowances on the IA W-4, the calculation is as follows:

$$(\$9,500.00 - \$9,140.00) \times 5.70\% + \$352.61 = \$373.13$$
