Iowa Leading Indicators Index September 2008 Report

Tax Research and Program Analysis Section

The Iowa Leading Indicators Index (ILII) fell to 105.9 (100=1999) in September 2008 from 106.5 in August. The Iowa non-farm employment coincident index again inched up 0.03 percent for the month.

The ILII's value in September decreased 0.6 percent, matching the 0.6 percent drop in July and exceeding the 0.5 percent drop in June and the 0.4 percent drop in August. The index has decreased for the last six months from its peak value of 108.4 in March. During the six-month span through September, the ILII dropped 2.3 percent (a -4.6 percent annual rate). The six-month diffusion index (value of 25.0) reflects two of eight components experiencing a 0.5 percent or greater increase over the last half year, the agricultural futures price index and the yield spread, and the remaining six components experiencing a 0.5 percent or greater decrease.

In September, two of the eight Iowa Leading Indicators components increased. The positive contributors were the yield spread and the agricultural futures price index. The negative contributors were average weekly manufacturing hours, the new orders index, unemployment insurance claims (inverted), new residential building permits, diesel fuel consumption, and the Iowa stock market index.

Figure 1. Iowa Leading Indicators Index and Iowa Non-Farm Employment Coincident Index: January 1999-September 2008



a. Percentage changes in the ILII do not always equal changes in the level of the ILII due to rounding.

b. A diffusion index measures the proportion of components that are rising based on the actual changes (not the standardized contributions to the ILII). Components experiencing increases greater than 0.05 percent are assigned a value of 1.0, components that experience changes less than an absolute value of 0.05 percent are assigned a value of 0.5, and components experiencing decreases greater than 0.05 percent are assigned a value of 0.0.

b. The agricultural futures price index is computed as the sum of the standardized symmetric percent changes in the four series, each weighted by the commodity's annual share of Iowa cash farm income (updated August 15, 2008).

d. Changes in unemployment claims are inverted when added to the ILII, thus a negative change in the series contributes positively to the index.

ILII Components

- **Yield spread:** Difference between the yield on 10-year Treasury bonds and 3-month Treasury notes. During September, the yield spread increased as the long-term rate fell 20 basis points while the short-term rate sank 60 basis points. This component contributed 0.10 to the ILII.
- **Agricultural futures price index:** Composite measure of cattle, hogs, corn and soybeans futures prices weighted by the respective share of annual Iowa cash farm income. Changes are calculated based on a 12-month moving average of the futures price series, where cattle and hogs series also incorporate estimates of break-even costs. During September 2008 this component contributed 0.07 to the ILII value as the 12-month moving average of corn and soybean futures prices continued their rise and expected hog profits increased while cattle profits dropped slightly. This component does not reflect the sharp drops in commodity prices that occurred during the month of October.
- **Iowa stock market index:** Capitalization-weighted index of 36 Iowa-based or Iowa-concentrated publicly-traded companies. Changes are calculated based on a 12-month moving average. In September 2008, 14 of the 36 companies and 9 of the 14 financial-sector companies gained value. The index contributed -0.04 to the ILII value. This component does not reflect drops in stock prices, particularly for financial companies, experienced during the month of October.
- **Diesel fuel consumption:** Number of taxable gallons of diesel fuel sold in Iowa. Changes are calculated based on a 12-month moving average. During September 2008 this component's contribution to the ILII value was -0.10 as diesel fuel consumption for the month decreased 6.9 percent relative to the prior year.
- **Building permits:** Number of total permits issued in Iowa for the construction of residential housing units. Changes are calculated based on a 12-month moving average. During September 2008 this component contributed -0.11 to the ILII value. September permits rose 10.0 percent above August's value but were 31.2 percent below the number reported in September 2007, pushing the 12-month moving average down by 4.0 percent. September 2008 permits were 41.4 percent below the historical average for September, based on reports from 1998 through 2007.
- **Average weekly unemployment claims:** Weekly average of initial claims for unemployment insurance in Iowa. Changes are calculated based on a 12-month moving average and are inverted when added to the ILII. During September 2008 this component contributed -0.13 to the ILII value with unemployment claims 94.3 percent above September 2007 claims.
- **New orders index:** Diffusion index measuring the share of purchasing managers in Iowa reporting increases in orders received for manufacturing output. Changes are calculated based on a 12-month moving average. The monthly new orders index value fell in September to 26.8 from August's 34.2, far below the September 2007 value of 60.0 and the lowest recorded value in the decade-long history of the index. With the low number reflecting lingering flood impacts and weakness in export-related activity especially in the nondurable-goods manufacturing sector, this component contributed -0.15 to the September 2008 ILII value.
- **Average weekly manufacturing hours:** Weekly average of hours worked in the manufacturing sector in Iowa. Changes are calculated based on a 12-month moving average. During September 2008 this component contributed -0.21 to the ILII value as September hours were 8.1 percent below the September 2007 report, pushing the 12-month moving average down by 0.7 percent.

The standardization factors are the inverse of the standard deviation of the month-to-month changes in each component over the January 1999 to June 2008 period. These factors equalize the volatility of the contribution from each component and are normalized to one. The month-to-month changes are based on 12-month moving averages for all components except the yield spread, which is the only national series. The yield spread and new orders index changes are simple arithmetic changes; month-to-month changes for the rest of the components are computed as symmetric percentage changes. The factors are updated annually during the summer.

Comments

The Iowa Leading Indicators Index is designed to forecast the likely future direction of economic activity in the State of Iowa. The techniques used to build the ILII follow those used by The Conference Board to construct the national leading indicators index. A movement in the ILII for only one month does not produce a clear signal, rather it is necessary to consider the direction of the index over several consecutive months. The Conference Board considers a contraction signal in the national leading indicators index reliable when two conditions are met: 1. the index declines by at least two percent over a six month period (using an annual rate); and, 2. a majority of the individual components also decline over those six months (six-month diffusion index less than 50.0).

The Iowa Non-Farm Employment Coincident Index measures the change in non-farm employment of all workers in the State of Iowa. Changes are based on a 12-month moving average of employment and are computed as symmetric percentage changes. The index is designed to represent the current state of economic activity in Iowa.

The Employment Index and the ILII are constructed to have a value of 100 in the year 1999.
