All software providers executing this agreement are subject to the confidentiality laws in Iowa Code sections 422.20, 422.72 and/or regulations of the Iowa Department of Revenue, including but not limited to provisions regarding who must comply with the law, definitions of "confidential tax information", what constitutes a disclosure, requirements for notice, civil and criminal penalties for unauthorized disclosure, and any exemptions.

I understand that if I provide any information that is untrue, inaccurate, obsolete, or incomplete, the Iowa Department of Revenue has the right to deny, suspend, or terminate my participation.
