

**SALES TAX
THE QUARTER IN REVIEW
COMPUTED TAX BY BUSINESS GROUP
QUARTER ENDING MARCH 31, 2008**

Computed Tax by business group during the March quarter of 2008 was \$371,228,483, an increase of 3.08% from the March quarter of 2007. The number of returns filed increased slightly from 80,543 to 81,624, a 1.34% increase.

Computed Tax by Business Group

There were three categories that had negative growth; Building Materials, Apparel and Specialty Retail. The remaining categories are showing positive growth but all are in the lower single digits. Sales tax receipts are slowing from previous quarters, a trend that is happening nationally as well.
