

**SALES TAX
 THE QUARTER IN REVIEW
 COMPUTED TAX BY BUSINESS GROUP
 QUARTER ENDING June 30, 2007**

Computed tax during the June 2007 quarter was \$415,607,888, an increase of 3.43% percent from the June 2006 quarter. The number of businesses filing returns increased from 79,996 to 81,231, a 1.54% increase.

Computed Tax by Business Group

The Utilities, Eating and Drinking, and the Miscellaneous groups had the best quarter over quarter growth of all the sectors, each showing quarter over quarter growth of over 6.00%. The Building Materials and the Wholesaler Goods groups both contracted.
