Sales and Use Tax Statistical Reports

Starting with the first quarter of fiscal year 2009, the Department has changed the way the Sales and Use Tax Quarterly and Annual Statistical Reports are prepared. The new methodology should result in a larger share of the retail sales activity being reported in the quarter during which it occurs and a corresponding reduction in the number of late-filed returns included in the reports.

This means that beginning with the September 2008 quarterly report the taxable sales and computed tax amounts report by city and county may not be exactly comparable to earlier reports.

As time permits the Department will be revising quarterly reports from prior years to allow users of the information to make more accurate historical comparisons of retail activities within their jurisdictions.

**THE QUARTER IN REVIEW
 COMPUTED TAX BY BUSINESS GROUP
 QUARTER ENDING SEPTEMBER 30, 2008**

Beginning July 1, 2008, the state sales and use tax rate increased from 5% to 6%, a 20% increase. The computed tax for September 2008 reflects this increase.

Computed tax during the September quarter of 2008 was \$533,087,388 which is an increase of 25.91% from the September quarter of 2007. Taxable sales during the September 2008 quarter totaled \$8,932,468,772, which is an increase of 5.48% from September 2007 quarter. The number of businesses filing returns also increased from 81,370 to 84,714, an increase of 4.11%.

Computed Tax by Business Group

During the September quarter of 2008, the Miscellaneous Sector had an effective increase of 14.32% followed by Building Materials with an effective increase of 13.63%. A large part of the increase in the Building Materials category can be attributed to the rebuilding that took place after the floods in June of 2008.
