

**RETAIL SALES TAX
THE QUARTER IN REVIEW**

**COMPUTED TAX BY BUSINESS GROUP
QUARTER ENDING SEPTEMBER 30, 1998**

Computed tax during the third quarter of 1998 amounted to \$346,397,336 an increase of 4.8% from the same quarter in 1997. The number of businesses filing returns decreased from 92,574 to 90,617 or -2.11% during the same period.

Computed Tax By Business Group

During the third quarter of 1998, the Miscellaneous and Building Materials Groups showed the largest increase in computed tax with 10.12.14% and 9.8% respectively. The Utilities Group followed with a 8.6% increase. All the business groups had a decline in the number of returns filed with the exception of the Utilities, General Merchandise, Food Dealers, and Miscellaneous Groups.
