

**THE QUARTER IN REVIEW**  
**COMPUTED TAX BY BUSINESS GROUP**  
**QUARTER ENDING December 31, 2003**

Computed tax during the fourth quarter of 2003 amounted to \$389,030,576 which is 1.4% growth from the December 2002 quarter. The number of business filing returns increased from 103,117 to 103,574 or 0.4% during the same period.

**Computed Tax by Business Group**

The Home Furnishings and Building Materials Groups showed the largest increase in tax with a 13.2% and 10.7% respectively. The phase out of the state sales tax on residential utilities is reflected in the 9.4% decline in the Utilities Group.
