

THE QUARTER IN REVIEW
COMPUTED TAX BY BUSINESS GROUP
QUARTER ENDING December 31, 2005

Computed tax during the December 2005 quarter was \$411,503,038, 2.45% growth from the December 2004 quarter. The number of business filing returns decreased from 103,507 to 102,094 or 1.37% during the same period.

Computed Tax by Business Group

There was good growth in many of the categories with Motor Vehicle and Apparel having the largest growth with 7.22% and 7.08%. General Merchandise was the only category showing a decrease from the December 2004 quarter.
