**RETAIL SALES TAX
 THE QUARTER IN REVIEW
 COMPUTED TAX BY BUSINESS GROUP
 QUARTER ENDING DECEMBER 31, 2006**

Computed tax during the December 2006 quarter was \$422,518,162, 2.68% growth from the December 2005 quarter. The number of business filing returns increased from 102,094 to 105,540 or 3.38% during the same period.

Computed Tax by Business Group

There was negative growth in four of the twelve major categories for the December quarter. In the housing sector there was negative growth in Home Furnishings category and growth was flat in the Building Materials category. But the General Merchandise and the Services categories both showed good growth.
